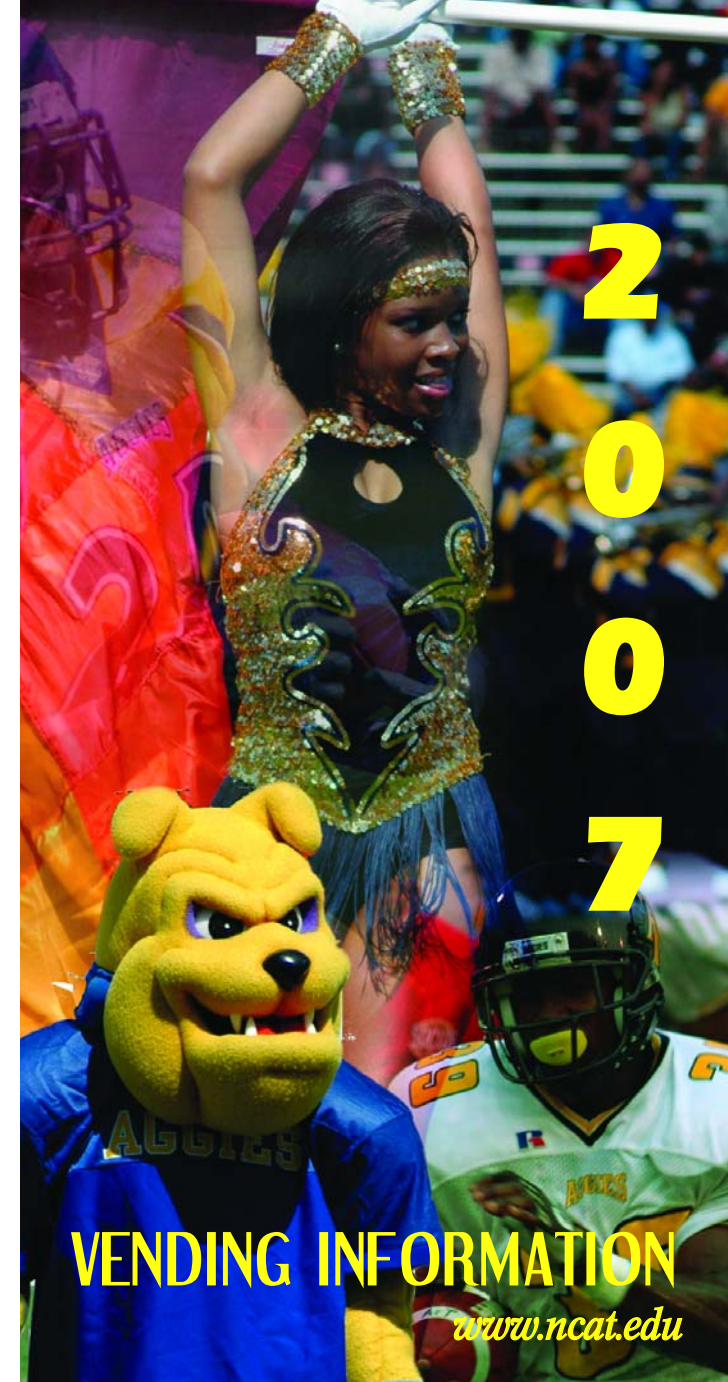

VENDING GUIDELINES



- All vending must be approved through the Office of Auxiliary Services.
- Persons, firms or organizations wanting to conduct sales activities or business solicitations on campus must submit a "Vendor's Application" to the Auxiliary Services Office.
- The University Vending Coordinator will review the application and notify the vendor of the status of their request.
- Approved vendors must pay a vending fee to set-up. The fee must be paid by money order, credit card or cash before selling is permitted.
- A vending permit will be issued on the day of set-up and a valid vending permit must be displayed upon request.
- All set-up material is to be provided by the vendor, to include tables. Vendors are allowed only two (2) tables.
- All table covering will be provided by Auxiliary Services. All covering must be returned to Auxiliary Services upon the end of your event.
- Any violation of these terms & conditions will result in having your ending privilege revoked.
- The University is not responsible for vending sales in the event of inclement weather. NO REFUNDS.
- Permits are issued between the hours of 8:30 am through 4:30 pm for campus vending during Monday - Friday.
- A maximum of three vending passes will be issued, for stadium vending. All people in your party must enter the gate at the same time.
- Tobacco, alcoholic beverages, and other prohibited substances are not permitted for sales, information or sampling.
