

## University Employees Campaign (UEC) FAQs

### ***What is the University Employees Campaign (UEC)?***

The University Employees Campaign is an annual fundraising effort that provides all A&T employees and retirees an opportunity to directly support their area of choice at the university.

### ***Why should I give?***

Your contribution is a vote of confidence in North Carolina A&T State University and its mission. Your gift will allow us to create the future 'now' for current and future students.

### ***How is the University Employees Campaign different from the SECC?***

Gifts to the University Employees Campaign stay here at A&T and will benefit our university, while contributions to the SECC allow the university family to support our community. The SECC is a worthy cause, but gifts to the SECC Campaign do not directly benefit A&T.

### ***Why am I being asked to give to both campaigns?***

We want you to continue to financially support our community organizations as well as our own university with a direct gift.

### ***I don't have much to give. How can my small contribution make a difference?***

Every gift and every donor makes a difference here at A&T. What is important is that you give, and not necessarily the amount you give. With each person doing what he or she can, collectively, we all can make a big difference.

### ***Can I decide how I want my gift to be used?***

Yes. In addition to the academic units, there are many programs, scholarships and funds to choose from when deciding what it is that you want to support at A&T. Each fund has a specific purpose so be sure you review the designation list to see what area will benefit from your gift.

### ***Can I designate my gift to support more than one area?***

Yes. Be sure to indicate all the areas you wish to support on the gift form.

### ***I am also an alumna/alumnus of A&T. Will my UEC contribution count towards my class reunion gift this year?***

Yes. Your UEC gift, made to any designation, will count towards your class reunion totals for this fiscal year as long as it is made by June 30<sup>th</sup>.

### ***What if my spouse works for a matching gift company?***

If your spouse works for a matching gift company, your gift to A&T may be doubled or even tripled. Check with the company's Human Resources Department to request the company's matching gift form. Then complete the form and return it to Advancement Operations. Visit [www.matchinggifts.com/ncat](http://www.matchinggifts.com/ncat) to see a list of matching gift companies.

***Is my gift tax-deductible?***

Yes, to the extent allowable by law. Once your gift has been processed, you will receive a receipt verifying the tax deductibility of your gift.

***How can I give?***

There are many ways to make your gift. In addition to your UEC form, here are a few convenient options:
